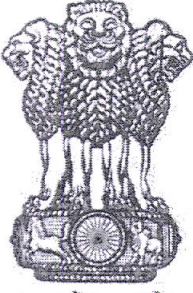

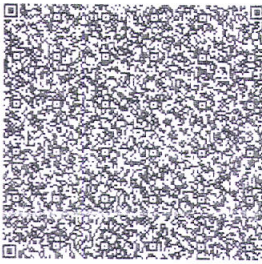

AGREEMENT FOR ACQUISITION RIGHTS

This agreement is made on 18th Sept. 2017 between Uttarakhand Open University, Transport Nagar, Teenpani Bypass, Haldwani, represented by the Registrar of the University (hereinafter called "The Licensee" and this expression shall include his successors and assignee) on the one part, and the Indira Gandhi National Open University, Maidan Garhi, Delhi 110068, represented by the

Statutory Alert:

2. The onus of checking the legitimacy is on the users of the certificate.

Registrar of the IGNOU (hereinafter called IGNOU and this expression shall include his successors and assignee) on the other part and vice-versa.

Whereas both the above institutions wish to make use of the printed instructional material of each other (IGNOU/UOU, as the case may be) designed for the various courses by way of acquisition of reproduction rights and supplying them among the students for the courses offered by the respective University.

NOW IT IS HEREBY AGREED AS FOLLOWS


- (i) This is an agreement to mutually use the instructional materials of IGNOU and UOU for an initial period of three years, from the date of this document.
- (ii) IGNOU and UOU hereby grant to each other the acquisition of reproduction and translation rights of their study material (as given in the Annexures) for distribution among the students of the respective Universities.
- (iii) The following terms and conditions govern this agreement
 - (a) IGNOU and UOU will supply to each other a hard as well as a soft copy of said courses printed by IGNOU/UOU to be used as a copy for further processing and printing at the cost to be borne by the user institution.
 - (b) No change in the text shall be made when it is reprinted except for the following :
 - (i) The print line, mentioning the name of the press where it has been printed should be substituted by a print line giving the name of the press where it is reprinted.
 - (ii) Due acknowledgement must be made, of the permission to reprint given by IGNOU/UOU, at a prominent place in each copy of the material.
 - (iii) The updating of data and/ or error rectification as an addendum/errata on a separate sheet must be given with prior permission of IGNOU/UOU.
 - (iv) Printing of the logo of both the institution must be given.

- (c) It should be ensured that the print quality of the material is as per standards of the IGNOU/UOU in respect of quality of paper and printing, cover printing etc.
- (d) While using the printed instruction material, IGNOU/UOU may use audio-video cassettes prepared by IGNOU/UOU.
- (iv) Any breach of this Agreement shall nullify this document.
- (v) Copy rights in respect of the concerned course material are reserved with the respective Universities.
- (vi) This dispute in respect of this agreement shall be subject to the jurisdiction of Delhi courts only.
