Title of Programme: Diploma and Certificate Programme in Goods and Services Tax

I. Programme's Mission & Objectives

The basic objectives of the programmes are ;

- To understand the concept of GST.
- To provide the basic knowledge about rules and laws related to GST.
- To provide basic understanding about procedural aspects related to GST using Tally.
- To provide the initial understanding about the technical aspects relating to GST.
- To enable the learner to submit forms and documents related to GST.

II. Relevance of the program with HEI's Mission and Goals:

The programme has been designed to impart overall understanding of GST Law covering its implementation, compliance and enforcement. The programme intends to meet the growing demand of personnel who are well versed with the provisions of the new GST Law so that they can handle tax compliance issues like invoice making, registration and calculation of tax liability under the new tax regime. Thus, the Programme has been fulfilling the University's objective to provide technical professional education to the distant learners of Uttarakhand. Further, the Programme has been fulfilling the University's mandate of enhancing employability skills of the learners.

III. Nature of prospective target group of learners:

The learners for the Course shall be admitted directly. The programme shall be offered to the students who have completed 10+2. Further, this programme shall also be offered to working professional including accountants, assistants, executives etc. serving in various capacities in different organizations.

IV. Appropriateness of programme to be conducted in Open and Distance Learning mode to acquire specific skills and competence:

The programme provides conceptual understanding about the technical aspects relating to GST. It has been designed to make the GST Law simple and easy to understand. Acquire practical knowledge of the different procedures required under GST Act, such as Registration, Filing of Returns, availing Input Tax Credit, TDS (Tax Deduction at Source for Government Buyers) compliance, and refunds.

The appropriateness of the programme offered in the ODL mode is ensured in terms of curriculum design, eligibility criteria, admission procedures, duration, evaluation, project work etc. The programme offered by the School shall be offered in modular structure starting from Certificate of Six months to Diploma of one year.

V. Instructional Design :

Instructional design is a scientific system that includes the principles of the effective design and

The successful distance learning design incorporates the unique learning requirements of adult learners. Prior to the development of the courses, curriculum assessment has been done and access devices and pedagogical tools have been applied for making curriculum. The contents of each course are divided into Blocks and Units. The entire study material is divided into small and manageable booklets to facilitate distance learners.
