3. You will not be entitled to any travelling allowance for reporting to join the said position.
4. Your engagement may be terminated at any stage without prior intimation and/or assigning any reason thereof.
5. The above engagement will not confer any right on your regular appointment in the University.
6. You will have to submit the enclosed undertaking.

The period of service rendered during this engagement will not be counted for the purpose of seniority. If any declaration given or information furnished by you proves to be false or found to have willfully suppressed any material information, you will be liable to be terminated and other such action as deemed fit shall be initiated against you. You will have to strictly abide by the existing rules and regulations enforced in University.

You will have to submit PAN for Income Tax purpose if any.
