**Subject: Offer for Appointment on the Post of Professor of Management Studies.**

Dear Sir,

With reference to your application for the post of **Professor of Management Studies** in the pay band of Rs.37,400-67,000 with grade pay of Rs.10,000 and the recommendation of Selection Committee duly approved by the Executive Council of the University in its meeting held on 9<sup>th</sup> August, 2011, I am pleased to inform you that you have been selected for the said post. The terms and conditions of the appointment are as under:

1. The appointment is purely temporary.
2. You will be on probation for a period of one year from the date of joining. The probation period may further be extended by another one year by the Executive Council (under provision of Statute 27(2)).
3. You will abide by all the provisions of the Act, the Statutes, the ordinances and regulations of the University as amended from time to time.
4. As approved by the Executive Council, your pay will be protected as per rule with benefit of two additional increments.
5. You can be transferred/posted on an equivalent post in any Campus of the University according to requirement.
6. Your service can be terminated on one month's notice or after paying you an amount equivalent thereof in lieu of notice or you may also tender resignation on similar conditions.
7. You will have to produce a medical fitness certificate from CMO/Deputy CMO of a government hospital.
8. You will have to execute the bond (being attached herewith) on a non-judicial stamp paper of Rs.100 duly verified by the notary.
9. You will also have to abide by the code of conduct, as applicable for teachers of the University.
10. Dearness and other allowances will be admissible to you according to the orders of the State Government.

In case the offer is acceptable to you, you may join on the said post by 8<sup>th</sup> September, 2011 on completion of all the requirements stated in this offer.
