## <u>Process of Submission of Admission Form by Candidates seeking fee</u> relaxation under the category of War widows/ Differently Abled (with 50% Disability)/ Women of Scheduled Tribe/ / Transgender Category

**Note**: The below mentioned process is valid for the respective Admission Session only. For every admission session, the process shall be repeated for the respective Admission Cycle.

1. An applicant, seeking fee relaxation in the above-mentioned category, has to fill-in the hard-copy of the Admission Form 2025, for the current academic session, available along with the admission prospectus 2025. The application form must contain all the eligibility documents for the programme and category claimed, along with the Disability/ Gender Certificate/ Relevant Certificate for claiming Fee Relaxation, and a Notary in a Rs 10/-stamp paper (in case of Differently Abled applicants) as per the format mentioned below:

- 2. The filled-in Admission Form, along with all the required documents, will have to be verified by the Regional Director/Assistant Regional Director of any one of the Regional Centre of the University, or the LSC Coordinator of Modal LSC Haldwani/Dehradun (LSC Code 16000/11000).
- 3. The filled-in application form (in Hard Copy), duly verified as mentioned above, will have to be submitted by the RC or Modal LSC to the Admission Section of the University at University's Headquarter Haldwani.

- 4. The last date for the completion of the entire process, as mentioned above, is 15 days prior to the last date of admission, *i.e.*, <u>the duly filled-in and verified admission form must reach the University Headquarter</u>; <u>Haldwani on or before 15 days prior to the last date of admission</u> for the respective Academic Session. After which, a payment link for the fee to be payable, by the eligible applicants, will be provided to the applicant in his/her registered email id.
- 5. Application received after the date mentioned in the above point no 4, will not be considered for fee relaxation and such applicant have to submit the entire fee for the respective program, as mentioned in the prospectus.
- 6. Other than then above provision for fee relaxation, there is no other provision of fee refund for such applicants mentioned in the above categories.
- 7. The fee relaxation mentioned in the above categories will be provided to the applicants/ learners enrolled only in/or the Modal LSCs (Haldwani/ Dehradun), or Special LSCs identified for a specific category, as mentioned/ defined in the Admission Prospectus.
- 8. The candidates/ learners must provide their own correct email id and mobile number for the entire process. In case of non-completion of the entire process, due incorrect email i.d. or phone number, the candidate will be solely responsible for the same.
