Candidates who have filled in registration form for MBA Programme shall have to compulsorily attend the Verification of Documents and Counselling at any of the given centers on the undermentioned dates for seeking admission.

2. Candidates who have filled in the registration form for MBA Programme must bring with them;
1. Completely filled-in Admission Form.
 2. Self-attested copies of required testimonials:
 - A. Marks sheet and Certificate of Class X.
 - B. Marks sheet and Certificate of Class XII.

- C. Marks sheet and Certificate of Graduation.
 - D. Marks sheet and Certificate of post-graduation (if claimed).
 - E. Category Certificate (if claimed).
 - F. Valid Identity Proof
 - G. Aadhar Card
 - H. ABC I.D. Card
 - I. DEB I.D. Card
 - J. Affidavit (if required)
 - K. 2 Passport Size Photographs
3. Originals of the above-mentioned testimonials (only for verification).
4. The admission shall be complete only after completion of the entire process and payment of fees. Other rules and regulations of UOU, regarding admission, shall be applicable as and where required.
5. Candidates are compulsorily required to bring Aadhar Card for the verification. Further, after the verification of documents, candidates who are found eligible for admission to the MBA Program are required to create an ABC ID and DEB ID for the purpose of seeking admission. For creating ABC and DEB ID, eligible candidates should have the following:
- a) **Aadhar Card**
 - b) **Access to their email address**
 - c) **Access to their registered phone number**
 - d) **Applicants are instructed to visit <https://uou.ac.in/abc> for ABC Id creation and <https://deb.ugc.ac.in/StudentDEBId> for DEB id creation before coming for Document Verification and Counselling.**
6. Counselling and documents verification fee shall be Rs. 500. The **Counselling and Document Verification Fee** of Rs 500 must be paid separately at the time of seeking admission. This fee can be paid through a QR code or through UOU Accounts Section using swipe Machine (at headquarters only) or Bank Challan.
