Spl.Ed.-ODL course to be conducted only at those Institutes who fulfils the prescribed 11. eligibility conditions to become Study Centre(s) as mentioned at para (i) & (ii) of 6.1 of Norms and Standards of ODL, 2015 of RCI and No Objection Certificate (NOC) has been issued by the Council to these Study Centres.
- Inspection team deputed by the Council will visit the University and submit its report to the 111. Council, once the normalcy is restored, as communicated by the Council earlier.
- Admission process to be commenced under intimation to the Council. Study Centre wise list IV. of admitted candidates in B.Ed. Spl.Ed. -ODL course during the academic session 2020-21 along with allocated intake to each centre may be submitted to the Council.
